GUIDELINES

You must follow the Criteria & Requirements outline to complete the narrative section of the application. Special attention should be given to “describe and highlight” those exemplary and unique aspects of the magnet school which are above and beyond program components found in traditional, non-magnet schools. For example, “having an active Parent Teacher Association (PTA)” is not considered a unique level of parent and community involvement specific to magnets. However, having a Friends of (School Name) that organizes parent volunteers for activities throughout the year is. Please spell out all abbreviations and acronyms, EXAMPLE: Supplemental Educational Services (SES).

Be sure to read all information carefully for the award appropriate to you.

Whole School or Program Within-A-School

Whole School is defined as every student in the school, 100% of the student population is in the magnet program.

Program Within-A-School programs must consist of at least twenty percent (20%) of the student population involved in the program OR a minimum of 150 students.

Magnet School of Merit or New & Emerging School of Merit

New & Emerging Magnet School category is designed for magnet schools or programs within-a-school in their third or fourth year of implementation.

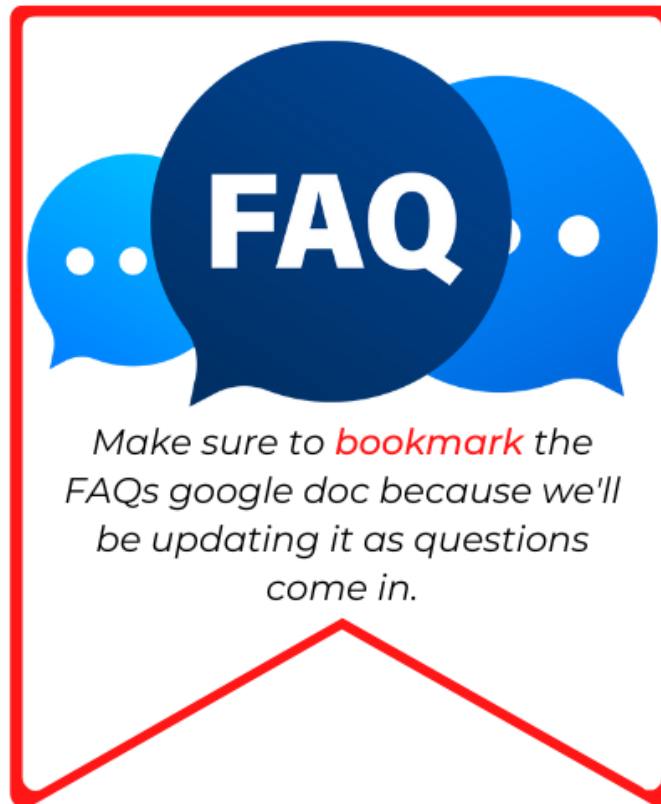
